NTEGRATOR AWARDED MAIDEN S\$1.5 MILLION CONTRACT FOR CIVIL WORKS ON CABLES DIVERSION BY DAEWOO-YONGNAM JOINT VENTURE

- Group secured S\$1.5 million contract for civil works on cables diversion along Jurong Town Hall (before Ayer Rajah Expressway), Jurong Gateway Road and International Business Park in Singapore for a major Land Transport Authority ("LTA") project
- Group continued to generate healthy contract winning momentum in the region and this contract win adds onto its outstanding order book of S\$65.9 million as of 30 June 2021

Singapore, November 12, 2021 – Ntegrator International Ltd ("Ntegrator" or the "Group"), a leading regional communications network specialist and systems integrator, today announced that it had secured a contract worth approximately S\$1.5 million from Daewoo Engineering & Construction Co Ltd ("Daewoo") and Yongnam Engineering & Construction Pte Ltd ("Yongnam") Joint Venture (together, "Daewoo-Yongnam JV") for civil works on cables diversion in the western region of Singapore. This contract commenced on 8 November 2021 and is expected to be completed by 15 April 2022.

The scope of the contract shall include but not be limited to the following: procurement of High-Density Polyethylene ("**HDPE**") Polyvinyl Chloride ("**PVC**") pipes, installation of manhole and manhole cover, Bar Reinforced Concrete ("**BRC**") iron mesh, portland cement, provision of labour for pipe laying works and project management services with all related agencies and other contractors for mill and patch etc.

In July 2020, Daewoo-Yongnam JV secured a S\$320.4 million contract from Singapore's LTA for the design and construction of three Jurong Region Line ("**JRL**") stations as well as

the associated viaducts¹. These include Toh Guan, Jurong Town Hall and Pandan Reservoir stations and viaducts spanning 3.6 km in Singapore.

Commenting on the contract win, Mr. Christian Kwok-Leun Yau Heilesen, Executive Director of Ntegrator, said: "Both Daewoo and Yongnam are world class partners in the infrastructure industry across the region, we are very honoured and grateful to Daewoo-Yongnam JV for choosing Ntegrator for this unique opportunity and we look forward to working with them on this project and more in the near future."

Mr Jimmy Chang, Managing Director of Ntegrator, added: "We are delighted to win our first contract from Daewoo-Yongnam JV and we are hopeful of more similar opportunities going forward given our experience and track record in delivering quality contracted works timely in our industry. We will continue to pursue opportunities in Singapore, Vietnam, Myanmar and beyond by leveraging on our established working relationships with our customers and our business partners in the region."

The contract is not expected to have any material impact on earnings of the Group for the financial year ending 31 December 2021.
