## **RECEIPT OF WRIT OF SUMMONS**

The Board of Directors (the "Board") of Ntegrator International Ltd. (the "Company") refers to the Company's announcements dated 11 August 2021 and 27 August 2021 (the "Previous Announcements"), in relation to a letter of statutory demand dated 6 August 2021 from the lawyers of Asian Corporate Advisors Pte. Ltd. (the "Plaintiff") pursuant to Section 125(2)(a) of the Insolvency, Restructuring and Dissolution Act 2018 for alleged fees owing by the Company (the "Letter of Statutory Demand").

Further to the Previous Announcements, the Board wishes to announce that, in connection with the Letter of Statutory Demand, both parties represented by their respective solicitors did not come to any conclusion after several rounds of discussion and the Company had, on 1 April 2021 received a writ of summons dated 25 March 2022 ("Writ"), filed by Rajah & Tann Singapore LLP, the solicitors acting for the Plaintiff, against the Company in the State Courts of Singapore.

Pursuant to the Writ, the Company must:-

- 1. Satisfy the claim; or
- 2. Enter an appearance to defend the claim,

within 8 days after the service of the Writ, failing which, the Plaintiff may proceed with the action and enter judgement against the Company without further notice.

Pursuant to the Writ, the Plaintiff claims from the Company a total of S\$188,244.04 for services allegedly rendered by the Plaintiff to the Company.

The Company intends to enter an appearance in accordance with the Writ to defend the claim vigorously in consultation with its legal advisers, Shook Lin & Bok LLP.

The Company will make further announcements to update its shareholders when there are material updates in respect of the matter, as and when necessary.
