The board of directors ("**Directors**") of Ntegrator International Ltd. ("**Company**") refers to the announcements dated 11 August 2015, 3 November 2015, 11 November 2015, 19 November 2015 and 20 November 2015 in relation to the Bonus Issue ("**Previous Announcements**").

Unless otherwise defined, capitalised terms herein shall have the same meaning as ascribed to them in the Previous Announcements.

The Directors are pleased to announce that 807,858,632 Warrants and 99,465,945 Additional Warrants 2013 were issued on 25 November 2015 pursuant to the Bonus Issue and the Adjustment to Warrants 2013.

The Warrants issued and allotted to Entitled Depositors are expected to be credited into their Securities Accounts on 26 November 2015. Certificates for the Warrants have been despatched to Entitled Scripholders.

Certificates for the Additional Warrants 2013 have been despatched to Warrant 2013 Holders whose Warrants 2013 certificates had not been deposited with CDP.

With effect from 25 November 2015, the exercise price of the unexercised Warrants 2013 and the Additional Warrants 2013 shall be S\$0.014.

The Warrants and Additional Warrants 2013 will be listed and quoted on the SGX-Catalist with effect from 9 a.m. on 27 November 2015 and 26 November 2015 respectively.
