NTEGRATOR WINS TWO CONTRACTS, WORTH S\$22 MILLION, FOR THE NEXT GENERATION NATIONWIDE BROADBAND NETWORK

- Contracts awarded by Singapore's largest communications group, SingTel;
- Largest local contract secured todate;
- Total outstanding order book increases to S\$67.7 million

Singapore, September 10, 2009 – Ntegrator International Ltd ("Ntegrator" or "the Group"), a leading regional communications network specialist and systems integrator, has won two significant milestone contracts to roll out the Next Generation Nationwide Broadband Network ("Next Gen NBN") for Singapore's largest telecommunications group, SingTel. The two contracts awarded by SingTel are worth S\$22 million, the largest local contract secured by Ntegrator todate.

Commented Mr Jimmy Chang, Managing Director of Ntegrator: "The Next Gen NBN, when completed, will be a key milestone in Singapore's info-communications landscape, enhancing Singapore's status as an info-communications hub and raising our global profile. We are honoured to be able to participate in this highly anticipated and groundbreaking info-communications development, which reinforces our leading regional position in the network infrastructure systems integration industry."

A project under the Intelligent Nation 2015 (iN2015) master plan, it is envisioned that Next Gen NBN will eventually provide a nationwide ultra-high speed broadband access of 1Gbps and more to all physical addresses. This infrastructure is a critical national enabler to spur the development of new knowledge-based sectors such as

research & development and it will catalyse development and deployment of innovative interactive digital services to homes, schools and businesses. By 2010, 60% of homes and offices can expect to have access to this new, ultra high-speed, all-fibre network, and the network coverage is expected to expand to 95% by 2012.

Under the terms of the two contracts, Ntegrator will roll out the Next Gen NBN. The contract also includes an option for a six-month extension, exercisable at the sole discretion of SingTel. The contracts are scheduled to be completed by end 2012.

With the award of these two new contracts, the Group's total outstanding order book has been boosted to S\$67.7 million todate, representing a 41% improvement over FY2008's revenue of S\$47.9 million.

The two contracts are expected to have a positive impact on the earnings of the Group from FY2009 till FY2012.
