## NTEGRATOR IS NAMED ONE OF SINGAPORE'S MOST ENTERPRISING COMPANIES

Singapore, November 22, 2005 – Ntegrator Pte Ltd, a wholly-owned subsidiary of Ntegrator International Ltd ("Ntegrator"), a regional integration specialist for network infrastructure and voice communication systems, has clinched the 28<sup>th</sup> position in the 2005 Enterprise 50 ("E50") list.

Mr Jimmy Chang, Managing Director of Ntegrator, said: "We are delighted to be recognised as a top E50 company. Winning the prestigious E50 Award will serve to further raise our profile as a fast-growing company with a strong track record in the region.

"Prior to our successful Initial Public Offering recently, we already started venturing beyond Singapore in 2002 to capitalise on the growing telecommunications industry in regional markets namely Vietnam, Myanmar, Malaysia, Thailand and the Philippines. We went on to secure major contracts from leading telcos including MobileOne in Singapore, Viettel in Vietnam and the Ministry of Defence in Myanmar.

"Encouraged by our E50 status, coupled with our recent achievement of the Regional Headquarters Award from the Economic Development Board, we are focused on pursuing our next phase of growth by expanding our business in the region and tapping the opportunities in our specialist area of business."

Companies on the E50 list are ranked based on weighted averages of selected performance indicators such as operating profit before tax, turnover and profit growth over the last three years.

Launched in 1995, the E50 is organised by Accenture and The Business Times, supported by the Economic Development Board and International Enterprise

Singapore, and sponsored by DBS Bank.

Established in April 2002, Ntegrator's core businesses include the design, installation and implementation of data, video, fibre optics, wireless and cellular network infrastructure as well as voice communication systems. The Group provides project management services as well as maintenance and support services. Ntegrator has also recently expanded its business portfolio to include the provision of turnkey solutions for

medical equipment.

Ntegrator has expanded its operations regionally covering Singapore, Vietnam,

Myanmar, Malaysia, the Philippines and Thailand.

Ntegrator has been profitable throughout its three years of operations. The Group's net profit jumped 11-fold, from S\$287,000 in FY2002 to S\$3.3 million in FY2004 and its

revenue increased four-fold, from S\$7.4 million in FY2002 to S\$31.6 million in FY2004.

Ntegrator was listed on the SGX-Sesdaq on October 26, 2005. Ntegrator's IPO was sponsored by UOB Asia Limited.
