### **NTEGRATOR CLINCHES US\$23.5 MILLION CONTRACT WITH MYANMAR RADIO AND TELEVISION**

- **Largest-ever Contract Secured**
- **Material Impact on FY2007's Profitability**

*Singapore, December 4, 2006* – Ntegrator International Ltd (“Ntegrator” or the “Company”), a leading regional communications network specialist and systems integrator, today announced that it has secured a US\$23.5 million contract with state-run Myanmar Radio & Television (“MRTV”). This is the largest contract the company ever secured since it commenced operations in 2002.

The contract covers the supply, delivery, installation and commissioning of equipment and materials for a TV studio, radio studio and earth station, together with Fiber Optic network equipment and a TV and radio transmitter. MRTV is the older and more established of Myanmar's two state-run television stations, with four channels broadcasting news, education and entertainment in both Burmese and English. MRTV also jointly operates all seven of Myanmar's domestic pay channels.

Under the terms of the contract, Ntegrator will undertake engineering, planning and design of the system as well as supervise the physical installation to ensure quality of workmanship and a timely delivery. Post-installation, the Company is responsible for the thorough testing and commissioning of the individual equipment as well as the system as a whole. The Company will also assist in training MRTV staff to operate and maintain the new equipment.

Mr Jimmy Chang, Managing Director of Ntegrator, said: “This contract signals a significant milestone for us: not only for the record size of the contract but also the fact that Ntegrator is now recognized for the design and installation of large and complex integrated communications systems.

“We are delighted to be partnering MRTV in this project and our work will be helping to improve the quality and reach of the broadcast services they are able to offer to the people of Myanmar. “

In securing the contract, Ntegrator was able to leverage on its strong technical expertise and familiarity with the needs of the local market. Ntegrator first ventured into the Myanmar market in 2002 when it completed a network infrastructure project for the Government of Myanmar which involved the setting up of a telecommunications backbone linking 65 cities in the country. Subsequently, it supplied network infrastructure and voice communications services to Myanmar Post and Telecommunications, the nation’s main telecommunications operator. Ntegrator has since opened an office in Myanmar, with an appointed business representative to render technical services to its customers.

Added Mr Chang: “Four years ago, we identified strong potential for our services in the Myanmar market and have been working hard since then to extend our reach within the country. The present project owes much to the good work and excellent reputation we have built up over the past four years and is also a testament to the trust and strong working relationships we have developed with the Government of Myanmar. We hope this will serve to further enhance our reputation in the country and pave the way for more partnerships in years to come.”

Ntegrator also secured a separate US\$870,000 contract to supply transmitters, antennas and decoders to the Forever Group, Myanmar’s only private cable TV operator. With this contract, the company would be servicing two out of the three TV broadcasting groups in Myanmar.

Both contracts are scheduled to be completed in the next financial year and are expected to have a positive impact on the earnings of the Company for the financial year ending December 31, 2007.

Established in April 2002, Ntegrator's core businesses include the design, installation and implementation of data, video, fibre optics, wireless and cellular network infrastructure as well as voice communication systems. The Group provides project management services as well as maintenance and support services. Ntegrator's operations are located regionally covering Singapore, Vietnam, Myanmar, Malaysia, the Philippines and Thailand.
