NTEGRATOR MAKES INROADS INTO CAMBODIA TELCO SECTOR

- **Wins Two Contracts Awarded by Viettel Cambodia**
- **Secures Another Two Contracts from Viettel**
- **Total Outstanding Order Book Increases to S\$30 Million**

Singapore, May 7, 2008 – Ntegrator International Ltd. (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, announced today that it has made inroads into the Cambodian telecommunications sector through Viettel Cambodia.

Together with another two new contracts in Vietnam, Ntegrator has increased its total outstanding order book to S\$30 million, all of which are scheduled to be completed within the financial year ending December 31, 2008 (“FY2008”).

Mr Jimmy Chang, Managing Director of Ntegrator said: “FY2008 has started on a very strong footing. With strong demand in Indo-China, we have already secured S\$30 million worth of total outstanding orders – equivalent to 75% of our total revenue for the whole of last year.”

Under the terms of the Group’s two maiden US\$2.3 million (S\$3.1 million) contracts in Cambodia, awarded by Viettel Corporation, Ntegrator will supply, install and commission a Microwave system and a Synchronous Digital Hierarchy (“SDH”) infrastructure for Viettel Cambodia. These new telco infrastructure contracts are in line with Viettel Corporation’s plans to expand regionally in Indo-China. Viettel Corporation, a fixed line, ISP and cellular licence holder and the second largest telecommunications operator in Vietnam, also has a licence to provide telecommunications services in Cambodia.

Mr Chang commented: "While the value of the contracts may not be sizable, they are very significant as they represent a beachhead for Ntegrator to play a more active role in building up Cambodia's telco infrastructure and networks. On successful commissioning of both the Microwave system and SDH, we would be very well-placed to be considered for subsequent orders."

In addition, Ntegrator has also won two contracts worth US\$1.7 million (S\$2.3 million) from Viettel Corporation to expand its SDH infrastructure in Vietnam. This follows from an earlier contract awarded in December last year to provide a SDH backbone expansion to increase Viettel's infrastructure capacity.

"Over the past five years, we have worked closely with established telco partners in Vietnam with new contracts awarded to Ntegrator every year. This bears testimony to the high level of confidence our partners have in us - our technical core competencies, our products and services.

"We are heartened that our relentless efforts to grow the Group regionally has produced results. In addition to strengthening our foothold in Vietnam, one of our key markets, we have now penetrated into a new market in Cambodia. Moving forward, we will further leverage on our strong technical competencies, working hand-in-hand with our strategic partners in the region to fast-track Ntegrator's growth," Mr Chang added.

The four contracts, worth a total of US\$4.0 million (S\$5.4 million), are expected to have a positive impact on the earnings of the Company for FY2008.

Established in April 2002, Ntegrator's core businesses include the design, installation and implementation of data, video, fibre optics, wireless and cellular network infrastructure as well as voice communication systems. The Group provides project management services as well as maintenance and support services.
