### **NTEGRATOR RAMPS UP ORDER BOOK WITH US\$5.4 MILLION WORTH OF NEW CONTRACTS**

- **Two contracts for Viettel Corporation in Vietnam, and one for Viettel Cambodia**
- **Group's third contract win in Cambodia following maiden contracts in May**
- **Total outstanding order book increases to S\$25.4 million**

*Singapore, August 8, 2008* – Ntegrator International Ltd. (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, today announced that it has secured three new contracts from Viettel Corporation, Vietnam’s second largest telco operator. Viettel Corporation has been a major and valued customer of Ntegrator since the Group commenced operations in 2002, providing the Group with repeat contract wins totaling S\$13 million for the financial year ended December 31, 2007 (“FY2007”).

The three new contracts bring the Group’s total contract value secured from Viettel Corporation since the start of the year to US\$9.4 million (S\$13.0 million\*), which is equivalent to the total amount secured for FY2007. The Group’s total outstanding order book thus increased to S\$25.4 million, of which the majority is scheduled to be completed within the financial year ending December 31, 2008 (“FY2008”).

Out of the three contracts awarded, two will be for Viettel Corporation, which will involve the second installation of the Juniper’s Core Router for both of their fixed line and cellular networks and the installation of ECI’s XDM and BG-20 SDH multiplexer

systems for expanding their transmission network access capacities. A third contract was awarded for Viettel Cambodia, a subsidiary of Viettel Corporation, for the installation of ECI and BG-20 systems.

Commented Mr Jimmy Chang, Managing Director of Ntegrator: “Having established a strong presence in Vietnam’s telco infrastructure and network industry, we are now focusing our efforts to grow the Group in Cambodia – the next key market with tremendous growth potential.

“Thus, we are extremely encouraged by our third contract win in Cambodia, shortly after we made headway there with two maiden contracts awarded by Viettel Cambodia in May. Moving forward, we will maintain our strategic focus on growing the Group in the emerging countries in the Indo-China region, where rapid industrialisation has opened up ample opportunities for us to capitalise on.”

The three contracts are expected to have a positive impact on the earnings of the Group for FY2008.
