### **NTEGRATOR SET TO ATTAIN INNOVATOR STATUS IN AVAYA'S GLOBAL DEVELOPERCONNECTION PROGRAMME**

- **Firms collaborate under Avaya programme to develop cutting edge applications for the enterprise business communications arena, a market potentially worth \$30 billion in 2006**

*Singapore, April 5, 2006* – Ntegrator International Ltd. ("Ntegrator"), a regional integration specialist for network infrastructure and voice communication systems, today announced that its research and application development subsidiary, Ntegrator Sdn Bhd is set to attain the Innovator partner status in Avaya's DeveloperConnection ("DevConnect") Programme.

Avaya Inc. designs, builds and manages communications networks for more than one million businesses worldwide, including over 90 percent of the FORTUNE 500®, and is a leading global provider of business communications applications, systems and services. Its DevConnect programme is a global initiative for third-party developers to drive the creation of innovative applications for IP Telephony-based networks. It currently encompasses more than 2,200 software and hardware developer companies, integrators, service providers and customers.

Mr Jimmy Chang, Managing Director of Ntegrator, said: "We are pleased to attain innovator status in the Avaya's Global Developer*Connection* programme. We look forward to work closely with our business partner, Malaysian high-tech manufacturer G-TEK Electronics Group ("G-TEK"), to develop advanced communications products for both local and international markets. As innovator partners, Ntegrator will benefit from Avaya's expertise to develop products that complement its IP telephony solutions."

Under the DevConnect programme, Ntegrator and G-TEK would develop WiFi/GSM Mobile Phones and Session-Initiation-Protocol (SIP) Phones that are interoperable with Avaya's open-standards architecture and platform.

As a key original equipment manufacturer (OEM) and original design manufacturer (ODM) player in Malaysia, these products would therefore be manufactured at G-TEK's factory in Penang, Malaysia to cater to the Malaysian market initially, with the ultimate objective of marketing the products internationally.

As a member of the DevConnect programme, Ntegrator's benefits include: -

- ◆ Access to 2,200 companies for knowledge-sharing of the latest IP-based communications technologies;
- ◆ Opportunity to tap into the newly-defined and fast growing business communications applications segment, which is estimated to be US\$30 billion in 2006;
- ◆ Global access for its products in Avaya's markets; and
- ◆ Network with member organizations, which have expertise in a broad range of technologies including IP telephony, contact centers and mobility applications, as well as their ability to help companies extend the value of multivendor networks and transform voice into an intelligent business application that delivers true value to the bottom line.

Ntegrator and G-TEK would jointly develop products that cater to the small medium businesses (SMB) and Mid Market, both areas that Avaya is working to grow as part of its strategy to make Intelligent Communications a reality in Malaysia, as announced a year ago.

In conclusion, Mr Chang added: "As members of Avaya's DevConnect programme, Ntegrator and G-TEK would therefore join the rank of innovator, and will be recognized as part of a global programme that develops cutting-edge communications applications for vertical markets that are open, interoperable and highly available."
