NTEGRATOR SECURES S\$4.7 MILLION WORTH OF CONTRACTS FROM VIETTEL, SECOND LARGEST TELECOMMUNICATIONS OPERATOR IN VIETNAM

- To provide network infrastructure solutions in Vietnam

Singapore, September 18, 2006 – Ntegrator International Ltd (“Ntegrator”), a leading regional communications network specialist and systems integrator, today announced that it has secured two contracts, worth a combined S\$4.7 million, from Viettel Corporation (“Viettel”) to provide fibre optics network infrastructure solutions in Vietnam. Viettel is a fixed line, ISP and cellular license holder and the second largest telecommunications operator in Vietnam.

Under the agreement, Ntegrator will provide Viettel with a full turn-key Dense Wavelength Division Multiplexing (“DWDM”) optical backbone from Hanoi to Ho Chi Minh City. Once completed in early November, it will support up to 40 Channels, each capable of carrying a transmission bit rate of 2.5 Gbps of traffic. The first phase, which will cover the Hanoi and Ho Chi Minh City regions as well as 20 sites in between, will carry 8 Channels initially, although this is expected to rise to full capacity within 2 to 3 years.

In addition, Ntegrator will also be supplying the last mile Synchronous Digital Hierarchy (“SDH”) with drop and insert multiplexers capable of carrying 2 Mbps of traffic. This will allow Viettel to interconnect all its base stations with a Mobile Switching Centre (“MSC”), allowing them to expand traffic capacity as and when required.

The partnership leverages on Ntegrator's technical expertise in delivering world-class service and support and builds on established links between the two companies. In 2002, Ntegrator was commissioned by Viettel to supply, install and commission SDH fibre optics network infrastructure that allowed for E1 leased line services and telephone switching interconnection for country-wide access. Over the past 4 years, the company has been working together with Viettel on various infrastructure enhancements in Vietnam and the latest contracts build on this as part of Viettel's efforts to improve its networks in the south of the country.

Mr Jimmy Chang, Managing Director of Ntegrator, said: "We are pleased to be working with Viettel again on improving the capabilities of their network in Vietnam. This contract underscores the mutual respect and understanding that has grown between our two companies and builds on the successful work that we have done for them over the past 4 years. Viettel is constantly on the lookout to provide better and faster services to its customers and we are proud to assist them in their strategy of adopting the latest technologies to offer Vietnamese users newer, higher-quality solutions. The telecommunications market in Vietnam is developing rapidly, and with our good track record in this country, we are confident that we are in a good position to ride with this growth."
