NTEGRATOR SECURES TWO CONTRACTS WORTH S\$3.3 MILLION

- ***Contracts awarded by repeat customers include full turnkey solutions for the supply of communications equipment to Myanmar Radio and Television***

Singapore, April 29, 2013 – Ntegrator International Ltd (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, announced that it has bagged two new contracts worth a combined S\$3.3 million from repeat customers.

The first contract is for full turnkey solutions for the supply of FM transmitters to Myanmar Radio and Television (“MRTV”), Myanmar’s state-owned broadcast radio and television network. This repeat order closely follows an earlier contract in January 2013 for the supply of communications equipment.

The second contract is a Singapore project and it is awarded by an international information and communications technology solutions provider. Under the terms of the contract, Ntegrator will supply manpower for project management services.

The two new contracts are scheduled for completion in the current financial year and are expected to contribute positively to the Group’s financial performance in the financial year ending December 31, 2013 (“FY2013”).

Mr. Jimmy Chang, Managing Director of Ntegrator, commented, “Our strategic move into the Myanmar market has continued to bear fruit, as the country’s economic liberalisation continues to generate opportunities for industry players. It is especially encouraging for us that MRTV has once again chosen Ntegrator as its supplier – a strong testimony of our strengths and capabilities.”

“This latest contract further augments our strategy of increasing Maintenance and Project Management business as a percentage of our project-based business. We have made good progress in strengthening our order book in just the first four months of FY2013 and will continue to explore viable growth opportunities in the region with a view towards enhancing value for shareholders,” Mr. Chang concluded.
