### **NTEGRATOR USHERS IN 2014 WITH S\$4.02 MILLION WORTH OF ORDERS**

- ***First contracts of the year awarded by repeat customers Viettel Group, MOD Myanmar, Mitsubishi Electric and a regional telecommunications supplier***

**Singapore, January 22, 2014** – Ntegrator International Ltd (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, has started 2014 with four major contracts, worth S\$4.02 million, from repeat customers in the region. These contracts are for the supply of equipment and services to Vietnam, Myanmar and Singapore.

The first contract is awarded by the Viettel Group, Vietnam’s largest mobile network operator and a customer of Ntegrator since 2002, for the supply of laboratory equipment to its operations in Vietnam. The second contract is awarded by Myanmar’s Ministry of Defence (“MOD Myanmar”), for the supply of ECI Telecom’s transmission equipment and accessories to Myanmar.

The third contract, awarded by a regional telecommunications supplier, will see Ntegrator provide manpower and resources for the drawing-in/recovery of optical fibre cables in Singapore.

The fourth contract, awarded by Mitsubishi Electric Asia Pte Ltd (“Mitsubishi Electric”), is for the supply of telecommunications equipment for Fibre Distribution Frame with monitoring modules in Singapore.

Mr. Jimmy Chang, Managing Director of Ntegrator, commented, “We are off to an encouraging start for 2014, having secured contracts for three geographical markets in just the first month of the year. Backed by a positive global economic outlook and robust demand for network and communications hardware and services in the region, we are optimistic that business opportunities will continue to abound.”

“We are also delighted that customers have continued to place their confidence in our ability to deliver high quality products and services. The strong working relationships we have forged with our customers – influential market players in the region – position Ntegrator well for growth.”

All the four contracts are slated for delivery in the current financial year and are expected to bring positive contributions to the Group’s financial performance for the financial year ending December 31, 2014.
