NTEGRATOR SECURES S\$11.3 MILLION CONTRACT

- ***Awarded by a repeat customer for the supply of services involving pipeline and manhole works***
- ***Contract scheduled to commence in August 2016, with a contract period of three years***

Singapore, July 28, 2016 – Ntegrator International Ltd (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, today announced that it has secured a major contract worth S\$11.3 million from a regional service provider.

Based on contract terms, Ntegrator will be responsible for the supply of outside plants services involving pipeline and manhole works, including cable pulling and splicing. The contract is scheduled to commence in August 2016, with a contract period of three calendar years. The contract is expected to contribute positively to the Group’s financial performance over the next three financial years, subject to timely completion of the project and effective cost management and is not expected to have a material impact on the earnings per share and net tangible asset per share of the Group for the financial year ending December 31, 2016.

Mr. Jimmy Chang, Managing Director of Ntegrator, said, “Our latest contract win, which was awarded by a repeat customer in the network and communications space, signals our strong and continuing relationships with key industry players in Singapore and the region. It also adds to our earlier contract wins of \$11.0 million in Singapore and Vietnam, bringing our year-to-date order wins to over S\$22.3 million.



Moving forward, we will continue to seek leverage our competencies as a network and systems integrator as well as relationships with regional industry players to tap growth in our primary markets of Singapore, Myanmar and Vietnam.”
