NTEGRATOR WINS ORDERS WORTH S\$8.2 MILLION IN MYANMAR AND SINGAPORE

- Three supply contracts in Myanmar from repeat customers MRTV and MEC
- Two year contract for the supply of services for the installation, operation and maintenance of the Next Gen NBN in Singapore, with an option to extend for a third year
- Cumulative value of Ntegrator's year-to-date order wins at approximately S\$59.0 million

Singapore, June 22, 2015 – Ntegrator International Ltd ("Ntegrator" or "the Group"), a leading regional communications network specialist and systems integrator, announced today that it has secured four contracts worth S\$8.2 million from repeat customers in Myanmar and Singapore.

Two of the contracts were awarded by Myanmar Radio and Television ("MRTV"), Myanmar's state-owned broadcast radio and television network, and involves the supply of broadcast equipment such as Radio FM and DVB-T2 Transmitters. The third contract was awarded by Myanmar Economic Cooperation ("MEC"), a major Burmese conglomerate, for the supply of equipment, materials and services to support the microwave network integration in Myanmar.

The Myanmar contracts are slated for delivery in the current financial year and are expected to bring positive contributions to the Group's financial performance for the financial year ending December 31, 2015, subject to timely completion of the projects and effective cost management.

The fourth contract, which involves the supply of services for the installation, operation and maintenance of the Next Generation Nationwide Broadband Fibre Network ("Next Gen NBN") in Singapore, is for a period of two years (with an option to extend for a third year). This contract was awarded by a regional service provider and is expected to contribute positively to the Group's financial performance over the financial years ending December 31, 2015 to December 31, 2017, subject to timely completion of the project and effective cost management.

Mr. Jimmy Chang, Managing Director of Ntegrator, commented, "The latest contracts bring the cumulative value of our year-to-date order wins to S\$59.0 million, surpassing total orders of S\$27.0 million in FY2014. The encouraging contract win momentum in the first half of 2015 was supported by repeat customers in our core markets of Singapore, Myanmar and Vietnam, and we look forward to our continuing growth alongside many of our customers in the region."
