### RECEIPT OF LETTER OF STATUTORY DEMAND

---

The Board of Directors (the “**Board**”) of NTEGRATOR International Ltd. (the “**Company**”) wishes to announce that the Company has on 6 August 2021 received a letter of statutory demand dated 6 August 2021 from the lawyers of Asian Corporate Advisors Pte. Ltd. (the “**Previous Sponsor**”) pursuant to Section 125(2)(a) of the Insolvency, Restructuring and Dissolution Act 2018 for alleged fees owing by the Company (the “**Letter of Statutory Demand**”).

The Letter of Statutory Demand alleges, *inter alia*, that a total sum of S\$177,432.06 is due and owing by the Company to the Previous Sponsor, a breakdown of which is set out in the table below.

The Previous Sponsor has demanded payment within three (3) weeks from the date of receipt of the Letter of Statutory Demand, failing which the Previous Sponsor may commence winding up proceedings against the Company.

The Company disputes, *inter alia*, the alleged fees owing by the Company set out in the Letter of Statutory Demand, is seeking legal advice on the same to determine its next course of action, and intends to strenuously defend any winding up proceedings if such proceedings are commenced by the Previous Sponsor against the Company.
