- Group inked a Memorandum of Understanding ("MOU") with Gadmobe to collaborate and leverage on each other's expertise and market outreach

Singapore, 30 July 2021 – Ntegrator International Ltd ("Ntegrator" or the "Group"), a leading regional communications network specialist and systems integrator, today announced that it had entered into a non-binding MOU with Gadmobe Interactive Limited ("GIL") and Sasha Lab Limited ("SLL") (collectively, the "Gadmobe") to utilize each other's capabilities and to secure more business opportunities.

The MOU seeks (i) expansion of Ntegrator's business portfolio to include the provision of telecommunication software, (ii) exploration of new markets for Ntegrator's core businesses utilising Gadmobe's payment footprint, (iii) optimisation of Ntegrator's core businesses utilising Gadmobe's big data technology and (iv) leveraging on Gadmobe's advertising and e-commerce channels to expand Ntegrator's client portfolio.

In addition, the parties have agreed in the MOU to further explore other business ventures and opportunities in existing and new markets beyond the above mentioned as may be agreed between the parties. Following the signing of the MOU, all parties Page 1 of 2 will pursue the relevant approvals and conduct the relevant due diligence to further execute a Business Collaboration Agreement within three (3) months from the date of the execution of the MOU to officially kickstart the partnership. The Group also intends to convene an extraordinary general meeting to seek approval from the shareholders of the Company for the proposed business diversification that its entry into the Business Collaboration Agreement will result in.
