HUAWEI APPOINTS NTEGRATOR TO MANAGE SINGTEL'S OUTSOURCED COPPER-BASED VOICE AND DATA NETWORK INFRASTRUCTURE IN SINGAPORE

- *Huawei signs managed services contract with Ntegrator to assist in overseeing the daily operations and performance of three departments that were recently transferred from SingTel to Huawei*
- *Latest contract win in line with Ntegrator's strategy to grow its recurrent income stream*

Singapore, June 19, 2012 – Ntegrator International Ltd. (“Ntegrator” or the “Group”), a leading regional communications network specialist and systems integrator, is the beneficiary of SingTel’s recent outsourcing initiative, having secured a managed services contract (the “Contract”) from Sino Huawei Technologies Pte Ltd (“Huawei”). This is in line with Ntegrator’s strategy to build up a steady stream of recurring income through Maintenance and Project Management contracts.

The Contract comes on the back of an earlier announcement from SingTel in March 2012, which, as part of its restructuring plans, had outsourced around 500 jobs to Huawei.

The Contract will see Ntegrator deploy a Management Expertise Team (the “Team”) to Huawei to ensure the smooth running and performance of three departments of staff (approximately 300 employees). The Team will consist of five managers, with one of the managers being a Ministry of Manpower (“MOM”) qualified Safety Officer.

While Huawei has a five-year contract from SingTel, it has signed a one-year contract with Ntegrator, with an option to renew for a second year. Renewal for the third to the fifth year will be subject to further discussions between the two parties.

Mr Jimmy Chang, Managing Director of Ntegrator said: “This prestigious contract is Ntegrator’s largest managed services contract. To be entrusted to manage a network infrastructure for Southeast Asia’s largest telco is a clear endorsement of our Group’s technical expertise and quality service.”

“We have observed an emerging trend for the outsourcing of specialised management services and we believe that this contract with Huawei will pave the way for more such business opportunities for our Group. Moving forward, we will continue to monitor and tap on growth opportunities that the regional markets have to offer and we will work closely with major customers and business partners to grow our income streams, both in existing and new markets.”

The Contract is expected to contribute positively to the Group’s financial performance in the financial year ending December 31, 2012.
