NTEGRATOR WINS TWO COMMUNICATIONS EQUIPMENT CONTRACTS WORTH S\$3.4 MILLION¹

- Contracts awarded by Myanmar Economic Corporation and repeat customer Viettel Group
- Brings year-to-date order wins to over S\$74 million²

Singapore, October 31, 2013 – Ntegrator International Ltd ("Ntegrator" or "the Group"), a leading regional communications network specialist and systems integrator, has added another two contracts worth approximately US\$2.7 million (S\$3.4 million) to its order book, bringing total contracts won year-to-date to over S\$74 million, the highest since the Group's inception over a decade ago. These latest two contracts are for the supply of communications equipment to Myanmar, Cambodia and Mozambique.

The first contract is awarded by the Myanmar Economic Corporation ("MEC"), a major Burmese conglomerate, for the supply of equipment and materials for ECI transmission equipment and accessories to Myanmar.

Mr. Jimmy Chang, Managing Director of Ntegrator, commented, "The contract from MEC is of significance as it is our fourth contract for the Myanmar market this year. It is exciting that the emerging economy has continued to create opportunities for industry players and we will continue to leverage on our strong business networks and track record to secure new contracts."

The second contract is awarded by a repeat customer, the Viettel Group of Companies ("Viettel"), for the supply of Synchronous Digital Hierarchy ("SDH") equipment to Viettel's communication networks in Mozambique and Cambodia.

Mr. Chang added, "We are delighted to have secured more repeat orders from Viettel. This latest contract further reaffirms Viettel's strong trust and confidence in Ntegrator, enabling us to expand our business relationship beyond Indo-China to other markets. It is also especially encouraging for us to expand in symbiosis with Viettel as it develops and expands across borders and continents."

Both contracts are slated for delivery in the current financial year and are expected to bring positive contributions to the Group's financial performance for the financial year ending December 31, 2013.
