### **NTEGRATOR CLINCHES FOUR CONTRACTS WORTH S\$17.2 MILLION IN SINGAPORE AND MYANMAR**

- ***Project in Myanmar involves the supply of spare parts and ECI equipment to the Ministry of Defence***
- ***One of the three contracts secured locally is for the supply of services in relation to a broadband fiber network***
- ***The remaining two contracts are from a regional service provider which include a project to provide fiber works, while the other is an addition to an existing contract***

**Singapore, 2 February 2018** – Ntegrator International Ltd (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, today announced that it has secured four contracts totaling S\$17.2 million.

These contracts include a US\$2.0 million (approximately S\$2.7 million<sup>1</sup>) project in Myanmar, in which the Group will supply spare parts and ECI equipment to the Ministry of Defence and is expected to complete by 30 March 2018.

Under one of the three contracts secured in Singapore, the Group will provide services in relation to a broadband fiber network. These services include installation, patching and re-instatement works which commenced in January this year, covering a contract period of three years.

The remaining two contracts from a regional service provider include a project to provide fiber works, while the other is an addition to an existing contract to supply pipeline and manhole works.
