NTEGRATOR RECEIVES EDB'S REGIONAL HEADQUARTERS AWARD

Singapore, November 17, 2005 – Ntegrator Pte Ltd, a wholly-owned subsidiary of Ntegrator International Ltd ("Ntegrator"), a regional integration specialist for network infrastructure and voice communication systems, has received the Regional Headquarters ("RHQ") Award from the Economic Development Board ("EDB").

Ntegrator's RHQ Award allows it to enjoy a 15% concessionary tax rate for 3+2 years on incremental qualifying overseas income. Subject to the Group satisfying all the minimum requirements by the end of the third year of the incentive period, it will qualify for the 15% concessionary tax rate for an additional two years.

Part of the EDB's Headquarters Award programme, the RHQ Award was introduced in 2004 to assist local and foreign companies in accelerating their growth plans and to encourage them to root their presence in Singapore.

Mr Jimmy Chang, Managing Director of Ntegrator, said: "From the start, we set out to serve the regional markets in addition to Singapore. During the first year of our commencement of business in 2002, we secured major contracts from leading telcos – MobileOne in Singapore and Viettel in Vietnam. That led us to open our first overseas representative office in Vietnam the same year.

"To better serve our regional customers, we appointed a business representative in Myanmar and set up subsidiaries in the Philippines and Malaysia in 2003. Last year, we established another subsidiary in Thailand.

“This RHQ Award is timely, as we embark on our next phase of growth, following the successful completion of our recent IPO, the proceeds of which are slated to fund our business expansion.

“Ntegrator has the core competencies and a strong track record in the region. We believe that the RHQ Award will provide an additional impetus for us to expand further and tap the exciting opportunities that exist in the region for our specialist area of business,” he added.

Since the launch of the EDB HQ programme 10 years ago, over 350 local and international companies have received the Award, using Singapore as the springboard to the region.

About Ntegrator International Ltd

Established in April 2002, Ntegrator’s core businesses include the design, installation and implementation of data, video, fibre optics, wireless and cellular network infrastructure as well as voice communication systems. The Group provides project management services as well as maintenance and support services. Ntegrator has also recently expanded its business portfolio to include the provision of turnkey solutions for medical equipment.

Ntegrator has expanded its operations regionally covering Singapore, Vietnam, Myanmar, Malaysia, the Philippines and Thailand.

Ntegrator has been profitable throughout its three years of operations. The Group’s net profit jumped 11-fold, from S\$287,000 in FY2002 to S\$3.3 million in FY2004 and its revenue increased four-fold, from S\$7.4 million in FY2002 to S\$31.6 million in FY2004.

Ntegrator was listed on the SGX-Sesdaq on October 26, 2005.
