NTEGRATOR SECURES TWO CONTRACTS WORTH APPROXIMATELY S\$6.5 MILLION TO SUPPLY COMMUNICATIONS EQUIPMENT TO MYANMAR AND VIETNAM

- ***Year-to-date order wins at a record high of over S\$71 million¹***
- ***Repeat orders from Myanmar Radio and Television and Viettel Group are testimony to the Group's strong reputation for quality and service delivery with key players in the industry***

Singapore, August 29, 2013 – Ntegrator International Ltd (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, announced that it has secured two new contracts worth approximately S\$6.5 million from repeat customers, Myanmar Radio and Television (“MRTV”) and the Viettel Group of Companies (“Viettel”).

The first contract is for the supply of fiber equipment, transmitters and related communication accessories to MRTV, Myanmar's state-owned broadcast radio and television network. This marks the Group's third order from MRTV in the year-to-date, reflecting the strong traction Ntegrator has made in Myanmar.

The contract from Viettel is also a repeat order, for the supply of Dense Wavelength Division Multiplexing (“DWDM”) and Synchronous Digital Hierarchy (“SDH”) equipment to Viettel's optical and broadband network in Vietnam.

¹ The S\$71 million figure represents the combined value of contracts announced by Ntegrator since January 2013 and does not reflect its outstanding order book as of the date of announcement.

Mr. Jimmy Chang, Managing Director of Ntegrator, commented, “Backed by the continued support of our valued repeat customers, Ntegrator has continued to make good progress in our key markets in Indo-China. With these latest contracts, our year-to-date order wins stand at a record S\$71 million, the highest since the Group’s inception over a decade ago.”

“We are pleased that our strong track record for timely delivery of quality products and services has continued to yield us the support of our valued repeat customers; and that our efforts in developing business networks in the regional markets are continuing to pay off. Moving ahead, the Group will continue to proactively seek business opportunities from these two emerging economies that will strengthen our financial performance.”

These two new contracts are slated for delivery in the current financial year and are expected to contribute positively to the Group’s financial performance for the financial year ending December 31, 2013.
