NTEGRATOR NET PROFIT JUMPS 46.5% FOR FY2009

- Revenue improves by 16.7% to S\$55.9 million
- Group Net Profit was S\$0.9 million, an increase of 46.5% compared to FY2008
- Secures expansion contracts from leading Telcos in Singapore and the region
- Strong outstanding order book of S\$46.8 million as at December 31, 2009

Singapore, March 1, 2010 – Ntegrator International Ltd ("Ntegrator" or "the Group"), a leading regional communications network specialist and systems integrator, today announced a 46.5% increase in net profit of S\$0.9 million for the full year ended December 31, 2009 ("FY2009").

Revenue increased by 16.7% from S\$47.9 million the previous year ("FY2008") to S\$55.9 million in FY2009. The timely completion of several major projects in Vietnam contributed to the majority of the increase. Revenue was also boosted by project completion in Singapore.

Notwithstanding that, Project Sales recorded a moderate increase in revenue of 13.3% to \$48.2 million, gross profit jumped 147.9% to S\$5.4 million. The improved profit was mainly due to the decrease in finance cost, which had been accrued previously. The Project Management and Maintenance Services grew by 43.5% to \$7.8 million, mainly due to renewal of contracts by existing customers and project management services rendered by one of an overseas subsidiary. However, gross profit for this segment decreased by 57.3% to \$\$2.6 million because of lower margins from the overseas subsidiary. Nonetheless, project management delivered a healthy margin of 25%.

"Despite the challenges faced during the difficult period, the Group was able to record a healthy growth in revenue. Increase in revenue reflects the continued confidence and support of the Group's valued customers," said Mr Jimmy Chang, Managing Director of Ntegrator.

Outlook and Future Plans

The government expects Singapore's economy to expand by 4.5% to 6.5%, an increase from the previous prediction. The Ministry of Trade and Industry believes the electronics sector will benefit, due to a trend of increased global IT spending and inventory restocking. However, the Group is cautiously optimistic in line with the government's predictions.

"The Group will continue to focus on the emerging Indochina markets, with an emphasis on Vietnam as opportunities continue to open up. The outlook of Vietnam's market is pretty good. They will need more expansion to build up its 3G network," added Mr Chang.

The recent expansion plans on existing contracts with MobileOne Ltd, Viettel Import Export Limited Company, Myanmar Posts and Telecommunications and a new contract from Singapore Telecommunications Ltd, have increased the Group's total outstanding orders to S\$46.8 million. These secured contracts are largely scheduled to complete in FY2010 and therefore contribute positively to the Group's earnings accordingly.

Listed on Catalist (formerly known as SESDAQ) on October 26, 2005, Ntegrator's core businesses include the design, installation and implementation of data, video, fibre optics, wireless and cellular network infrastructure as well as voice communication systems. Established in April 2002, the Group provides project management services as well as maintenance and support services.

Headquartered in Singapore, Ntegrator has expanded its operations regionally, covering Singapore, Vietnam, Myanmar, Malaysia and Thailand.
