NTEGRATOR SECURES SEVEN NEW CONTRACTS WORTH S\$7.5 MILLION

Singapore, March 12, 2012 – Ntegrator International Ltd (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, announced that it has secured seven new contracts worth approximately S\$7.5 million.

The new contracts were awarded by various repeat customers, including Singapore Telecommunications Ltd (“SingTel”), Huawei International Pte Ltd (“Huawei”), the Viettel Group and the Myanmar Government. The new contracts are slated for progressive completion over the next six months and are expected to contribute positively to the Group’s financial performance in FY2012.

Commenting on the Group’s latest contract wins, Mr. Jimmy Chang, Managing Director of Ntegrator, said, “Securing these contracts attest to the Group’s capabilities and reflect the strong working relationships that we have with our key customers who are the leading telcos in the region. We believe that our solid track record and close partnerships with customers will put us one step ahead of competition as we continue to pursue growth opportunities amidst a challenging business environment.’

For the SingTel contracts, Ntegrator will supply various telecommunications and networking hardware including G.SHDSL extender equipment, clock cesium for network synchronization, transmitters and receivers, as well as other related network and communication systems.

Through Huawei, Ntegrator will supply and install Optical Distribution Frames for Singapore's second largest telco, M1 Limited's Long Term Evolution (LTE) service.

The contract from Vietnamese State-owned Viettel Group, the second largest mobile network operator in the country, is for the supply of Synchronous Digital Hierarchy ("SDH") equipment to Viettel Group's optical and broadband network in Vietnam. SDH equipment is primarily for high speed data transfer of telecommunication and digital signals.

Ntegrator will also supply the Myanmar Government ECI transmission equipment and accessories for the cellular mobile network infrastructure in Myanmar.
