### **NTEGRATOR'S ORDER BOOK RECEIVES S\$10.7 MILLION BOOST TO S\$39.1 MILLION**

- **Secures Eight Contracts including Three Project Management Contracts**
- **Maiden Project in Africa**

*Singapore, August 16, 2011* – Ntegrator International Ltd (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, has won S\$10.7 million worth of new contracts, bringing its order book to S\$39.1 million.

The Group has secured eight contracts with various customers, including repeat customers M1 Limited in Singapore and the Viettel Group of companies in Indo-China and Africa as well as two new Singapore customers: SMRT Light Rail and Matrix Networks. Of the eight contracts, three are project management contracts from repeat customers.

Scheduled to be completed in the second half of FY2011, these new projects are expected to contribute positively to Ntegrator's financial performance for FY2011.

“We are delighted to have secured more repeat business in both project management and maintenance services from our major customers in Singapore and the region. This reflects their confidence in Ntegrator's expertise and proven track record in high-tech network infrastructure and voice communication systems as well as our reliable 24/7 maintenance services.

“We are particularly pleased to have secured more maintenance contracts – both from repeat and new customers - as they represent a steady stream of recurring income,” said Mr Jimmy Chang, Managing Director of Ntegrator.

One of the contracts involves the supply of SDH equipment for Movitel Mozambique, a subsidiary of Viettel Global Investment Joint Stock Company, one of the Group’s biggest clients in Indo-china. This marks Ntegrator’s first foray into Africa.

“We will continue to partner our customers as they develop their telecommunications infrastructure networks in various countries around the world. Replicating our robust network system architecture, we are well-positioned to support our customers as they expand geographically.

“We are also delighted to have secured a beachhead with SMRT Light Rail, with the design, manufacture, installation, testing and commissioning of an ECI system which will link 13 operating LRT stations to the depot at Bt Panjang LRT station,” added Mr Chang.

Under the Group’s maintenance contracts, it provides onsite and online maintenance and support services. These services are supported by the Group’s 24-hour fault control hotline, hardware and software repair services, online CRM system services, 24-hour onsite support services and 24-hour remote modem dial-in services.
