NTEGRATOR SECURES CONTRACTS WITH TOTAL VALUE OF \$\$9.58 MILLION FROM VIETTEL

- Total of 4 contracts awarded by Viettel, Second Largest Telco in Vietnam
- Includes the supply and installation of the first-ever IP core router, the Juniper Core Router, to be implemented in Vietnam
- Expect to contribute positively to the Group's financial performance for FY2007

Singapore, December 7, 2007 – Ntegrator International Ltd. ("Ntegrator"), a leading regional communications network specialist and systems integrator, today announced that it has secured four more contracts worth a total of S\$9.58 million from Viettel Corporation ("Viettel"). Viettel is a fixed line, ISP and cellular license holder and the second largest telecommunications operator in Vietnam. This takes the total value of Viettel contracts secured by Ntegrator to approximately S\$13 million in the current financial year.

Mr Jimmy Chang, Managing Director of Ntegrator, said: "We have worked closely with Viettel over the past four years, and are delighted to be awarded another four contracts. These are on top of several contracts awarded to us by Viettel earlier in the year.

"Moving forward, we believe our strong relationship with Viettel will position Ntegrator well to benefit from Viettel's continuing thrust and expansion in the Vietnam telco space."

Under the terms of the Synchronous Digital Hierarchy ("SDH") Equipment contract, Ntegrator will provide Viettel with a SDH Backbone expansion to increase the infrastructure capacity of Viettel. With this expansion, Viettel will be able to increase its SDH access multiplexer capacity, which carries all of Viettel's traffic including voice, data and video.

In addition, Ntegrator will also supply and install the first-ever IP core router to be implemented in Vietnam. Using the Juniper Core Router, the global leading supplier for IP core routers, Viettel will help to boost the IP network infrastructure of Vietnam, providing various IP connections and applications. Upon completion, Viettel will be the pioneering local service provider to install an IP core router in Vietnam.

In relation to the installation of the IP core router, Ntegrator will also supply and install an IP DSLAM, which will provide Internet access to every Internet subscriber and/or user in Vietnam.

"We are delighted to be part of this exciting milestone development in Vietnam's telco industry. With the current low Internet subscriber base amongst the 84 million population in Vietnam, there is definitely significant room to grow our business in this market. With the rapid urbanization of Vietnam, we believe the potential for growth is high," added Mr Chang.

All four contracts with Viettel are scheduled to be completed by end of this year, and are expected to have a positive impact on the earnings of the Company for the financial year ending December 31, 2007.
